In the event **Kris Con Supply & Fasteners** finds it necessary to turn over my/our accounts to a collection agency or attorney, I/We agree to pay all cost and expenses of collection, including but not limited to attorney's fees and expenses.

INDIVIDUAL PERSONAL GUARANTY
